## 1. INTRODUCTION

The digest is meant to be a short version of your intended paper that facilitates quick and easy review [1]. The digest, starting with the ABSTRACT and ending with the CONCLUSIONS must be **at most FOUR pages long**. The REFERENCES section can exceed the 4 pages. Digests with less than three (3) pages (including references) will not be considered valid. Use at least 11 pt font (12 pt is preferred), single-spacing, single column and 1” margins. The digest has a total number of words including REFERENCES. Please bear in mind COBEP reviewers often have to review several digests; therefore, please do not submit a full length; single-spaced paper that is simply cropped down to four pages.

## 2. FIRST SECTION

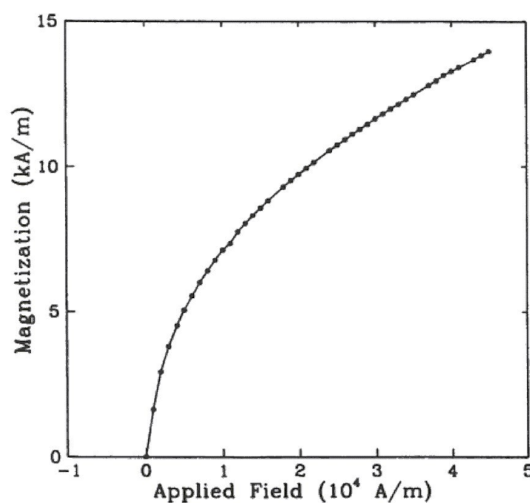


Figure 1: Sample figure.

Enter text, equations, figures and tables for your first full section here. The COBEP Technical Program Committee recommends following this format/template for digest preparation (see Appendix I for details). Figure captions should be centered below the figures (see Figure 1 as an example [2]), while table heads should appear centered above the tables (see Table I as an example). Insert figures and tables after they are cited in the text. Use the complete name “Figure 1”, even at the beginning of a sentence. It is suggested to use cross-reference as the model. The font size of any text within figures should be easily readable and comparable to the font size used in the figure captions.

It is suggested that you use table with two lines and without border to insert a graphic (which is ideally a 300 dpi TIFF or EPS file, with all fonts embedded) because this method is somewhat more stable than directly inserting a picture.

You are reminded that COBEP reviewers will prize experimental results and real-world applications, and as such, you should be sure to address these points in your digest. Evidence of completed experimental work will naturally be prized more than promises of future experimental work. Up to this point, the digest cannot exceed four pages.

### APPENDIX I (optional for the digest)

Before sending the digest for review, the COBEP Technical Program Committee will verify the validity of the submission. The following issues will be considered the main reasons for returning the digest to the author(s).

- The digest is too long (more than 5 pages)
- The digest is too short (less than 3 pages, including references)
- The digest is not anonymous: author details appear in the digest AND/OR in the pdf file properties
- The digest format cannot be accepted (e.g., not single-column, too small font, too narrow line spacing, the figures are of low quality, the reference is not in IEEE style, among others)
